

Covid

Here we are again, after a further six months since our Summer Newsletter, mentioning Covid. Fourth booster vaccinations are now available and the message is still the same, please 'GET VACCINATED,' as it is still our major defence against Covid and it can save lives. Records show that Covid has fewer sufferers than Flu, but that Flu has less serious results, due mainly to the Flu vaccinations, so the message is clear!

West Way Sports Hub – Phase 2 (New Play Area and Work to Pathways at the Site)

Astley Village Community Garden of Reflection

You will recall that, in the Summer Newsletter, the Parish Council consulted residents on the creation of a Community Garden in the village. The Parish Council at its meeting on 7 September 2022 agreed the following:

- The project and area be named the "Astley Village Community Garden of Reflection".
- A solid "Unknown Tommy Statue" be purchased with "A Time to Reflect" at the bottom and will be in place for the period immediately before and after Armistice Day each year. You will probably have already noticed the statue during October/November.
- On the front of the existing raised planter a sign will be included with "Astley Village Community Garden of Reflection".
- The Parish Council have accepted the offer of assistance from a resident of Astley Village and ex-Teacher and Garden Designer in developing the project.
- To purchase an additional cherry tree and two benches (with associated plaques to commemorate the late Queen and her Platinum Jubilee.
- The work will take place over the coming winter months.



Remembrance Sunday

Parish Councillors attended Chorley's Remembrance Sunday commemoration on Sunday 13 November 2022. As last year, a wreath was laid on behalf of the Parish Council.

New Finger Post Signs in the Village

A finger post sign on Chancery Road (near the subway) pointing to the "Village Centre", "Astley Park" and to the new "West Way Sports Hub" and a finger post sign on Judeland Wood to "Astley Park" have been installed.

Experimental Traffic order To Temporarily Make Chancery Road One Way

The Parish Council supported the experimental traffic order to make Chancery Road a one-way road during large events held in Astley Park such as the Flower Show, Bonfire and Fireworks Display and other events. The experimental traffic order will be reviewed annually by Chorley Borough Council following consultation with the Parish Council.

New Councillors Co-opted onto the Parish Council

At the Parish Council Meeting on 6 July 2022, Councillor Matt Frohock and Councillor lan Thomas were co-opted onto the Parish Council. Unfortunately Matt Frohock has recently had to resign due to time commitments. We welcome lan to our Council as his experience will and has already been a great asset to us.

Millennium Notice Board

The Parish Council have installed a new dual door notice board and steel sub frame to replace the previous Millenium Notice Board at the corner of Chancery Road and Hallgate. Parish information will be displayed on this and on the notice board at the corner of the Community Centre including details of Parish Council Meetings, in order to keep local residents informed of Parish Council activities.

West Way Ponds Community Nature Reserve and Wildlife Educational Project

The Parish Council is working with Chorley Borough Council to improve the West Way Ponds Community Nature Reserve.

The Ranger Team (Chorley Borough Council) have carried out urgent work and replaced the missing plank from the viewing platform and trimmed back the vegetation. Over the winter months the Parish Council will be embarking on a project to improve the area. See separate article in this newsletter on page 16.



Environmental Issues in the Village

Along with many residents, the Parish Council is concerned at the lack of grass cutting maintenance in front of and behind the shops at Hallgate. The Parish Council and Chorley Borough Council have written to the owner of the shopping centre regarding the lack of grass cutting in front and behind the shops at Hallgate and have asked that this be addressed as a matter of urgency. To date no reply has been received but you will notice that the grass has now been cut.

During 2022 there has been an increase in wanton and senseless vandalism at the subway under Chancery Road. Chorley Council has responded quickly to our requests www.avpc.org.uk 5

for reparation, but it shouldn't be necessary, our constant aim is to improve the Village for all our residents of whatever age and we can do without this vandalism.

At the meeting of the Parish Council held on 7 September 2022, Parish Councillors discussed issues raised by members of the public including the length of duration and noise levels experienced by residents as part of the music event held in Astley Park, particularly on the 22 and 23 July.

Chorley Borough Council, who have responsibility for approving and managing these events have now met with the organisers of the event to discuss the complaints received. An undertaking was given that the Parish Council would be consulted in the future, prior to the granting of permission for events involving live music events held in Astley Park.

Parish Councillors suggested that an acceptable decibel level be determined by Chorley Borough Council and that this should not be exceeded for future events held in Astley Park.

There have also been incidents of anti-social behaviour in the village in recent months which are being addressed and we soon hope to facilitate community litter picks in the village each month. See separate articles in this newsletter.

Introduction – Councillor lan Thomas

After finishing College in Liverpool, and a short summer job in North Wales, I joined the Royal Air Force and went on to serve for ten years. That included two overseas tours in Germany and based in East Anglia and Staffordshire. Went I left the Air Force in 1977, after a Christmas Job with the Royal Mail I joined British Aerospace. I used to joke at this time that I was doing the same job as did in the Air Force with Aerospace but at least I got home on time every night.

Newly married, I was given a flat in the newly built Clayton Brook. It was so new that we often had to direct the bus drivers through the village. After three years we bought our own house in Preston and I continued working for BAE until 2001 when I took redundancy.



Trying to find new work was not easy, but after six months I found work in the Civil Service. Over the next sixteen years I worked in offices at Preston, Warrington, and Burnley. After retirement I went on to be a volunteer worker with the Royal Air Forces Association Wing Centre in Preston. Picking up some skills I did not know I had, including a certificate in Food Safety in Catering, so I could cook and serve breakfast to the ex-serviceman the breakfast club. Regrettably the Wings Centre closed due to COVID-19 and will not now reopen.

The COVID-19 endemic made us mindful of how important family is and in 2020 we moved to Chorley to live near our daughter and son in law. I have since been elected to the committee of Royal Air Forces Association Leyland and District branch (branch covers Chorley) and I act on the committee as Welfare member, and Wings Appeals Co-ordinator.

I was co-opted Ashley Village Parish Council on 6 July 2022, and have been enjoying the role ever since, with the highlight so far being able to help, along with other Councillors, on the Astley Parish Council stall at the Chorley Flower show.

Litter

Litter consists of waste products that have been discarded incorrectly, without consent, at an unsuitable location.

This is a very succinct definition for something that is a perennial problem in our village and in the wider community. Litter in our country's streets costs almost £1 billion a year to clean up and that doesn't cover clearing up waste from parks or public spaces. To put it another way that amount of litter would fill the space of Wembley Stadium four times over, weighing in at 30 million tonnes.

* More than 2,000,000 pieces of litter are dropped in the UK every day!!

* 1,300,000 pieces of waste materials are discarded on roads and into kerbsides every weekend and a survey found that a third of motorists admitted to littering when out driving.

* Have you ever dropped orange peel or a banana skin? It may surprise you to know these take up to two years to biodegrade. Plastic bags can take 10-20 years to biodegrade and plastic bottles take an estimated 450 years. No-one has lived long enough to find out exactly!!

* Litter in the UK has increased by 500% since the 1960's.

One of the Parish Councillors took a walk around Astley Village with their camera at the beginning of October and here are a few examples of what they found.



The amount of litter in Astley Village is unsightly and frustrating and reflects very badly on our community. To be fair some of the litter is left by visitors to Astley Park and dropped by drivers as they pass by on Chancery Road.






However there are places obvious to any residents, where teens and adults gather and discard litter, even though there are bins provided, a few paces away, by the bus-stops and the shops and take-away in the village centre.



Is it too far to walk to deposit litter in the bins provided?

I'm lazy and selfish

Don't be a 'tosser' Dispose of your rubbish responsibly Maybe this sign is too "provocative"? However it does highlight the main question. WHY DO PEOPLE DROP LITTER?

It almost seems that individuals buy packaged items to consume as they are walking but find that they are "too

heavy" to carry as soon as they are finished!

How ironic to drop an empty bottle of Lucozade energy drink!

With the arrival of new fast-food outlets in the vicinity, it is



obvious that Starbucks, Macdonalds, and Greggs packaging is making an unwelcome appearance on our footpaths, woodland walks, roads and kerbside borders.







But what can be done about it? Would signage like these examples make a difference?





Would dual purpose bins,like the ones in Chorley town centre, prompt individuals to recycle rather than discard bottles and cans onto our streets?

Parents can educate their children and the messages about the harmful effects of discarded waste, especially bottles and cans, are highlighted in the curriculum at Buckshaw Primary School. Hopefully this will help the pupils and future citizens to understand the problems of littering and for the need to re-cycle as much waste material as possible, in order to conserve raw materials and to protect their future environment and wildlife.

Astley Village Parish Council volunteers will be holding Litter Picking sessions on the first Saturday morning of each month and would like to encourage as many residents as possible to join us, as we target well known littering spots around the Astley Village. The Parish Council have litter pickers and bags for volunteers to use, so please bring your enthusiasm and meet up at the Community centre at 10am on 7 January 2023.

As long time residents of Astley Village, we are proud of living in such a green and usually clean place. As noted in the Chair's Report, there are certain areas around the Community Centre, which are not the responsibility of either Chorley Borough Council or the Parish Council and we have asked the owner to address the problem.

A growth in the number of takeaway food and beverage outlets had come at the same time as a squeeze on council budgets and services, so greater quantities of litter are now less likely to be cleared away. Research by "Keep Britain Tidy" has established that people will drop litter far more readily when they see litter is already there, and so the problem gets worse. Litter also signals a lack of local care and is linked to higher levels of graffiti, vandalism and crime.

Litter Picking is a very worthwhile task but it is important to note that there hazards to avoid and sensible tips to promote participants safety.

Noxious and Dangerous Materials

- Broken Glass remove using a litter picker or brush and shovel, avoid contact with hands.
- Drug related/hypodermics do not remove. Note the location and report to Chorley Borough Council for specialist removal.
- Suspect materials and fly-tipping. Unknown liquids, building materials, asbestos, should not be moved by volunteers. Their position should be noted and reported to Chorley Borough Council.

General Site Safety and Inspection

Litter picking of areas beside roads should be carried out with extreme caution, due to the risk of being struck by vehicles.

Litter pick one side of the road at a time (to avoid crossing) and should be carried out facing oncoming traffic, only litter pick where there are pavements. It is essential that volunteers are visible to road users, for that reason, hi-visibility waistcoats must be worn and litter picks should only take place in clear daylight. Volunteers should not attempt to clear litter from the carriageway.

Avoid reaching into hedges or undergrowth in such a way as to expose the face, eyes and skin to scratches from thorns or branches. If an item of litter cannot be safely reached with a litter picker, leave it.

If you see someone fly tipping or come across hazardous waste, report it to the Environment Agency on its 24-hour hotline or, alternatively, contact the police.

Chorley Borough Counci's website mentions their Litter Policy. In addition to providing litter bins we also carry out litter picking. It is important that everyone takes responsibility for improving the environment by using the litter bins provided. If you do notice any littered areas, then please report this to us. We will then arrange for a team to attend and carry out a litter pick of the area.

It is an offence to drop litter on public land.

A fixed penalty notice of \pounds 75 may be served, payable within 20 days of the notice being issued. This will be reduced to \pounds 50 if paid within 10 days of the notice being issued.

We have a good number of signs concerning dog fouling in and around the village but few signs like those on page 10. It would seem that there were fewer instances of dog fouling since the campaign on dog fouling was promoted through signage.

Would more anti-litter signs help to make a difference?

Wildflower areas and Wildlife Corridors

The Parish Council has an ongoing commitment to work with Chorley Borough Council on the Mini-Meadows and Wildlife corridors project. As happened last year, this summer much of the grass verge along Chancery Road was left unmown to allow "wildlife friendly corridors" to develop. In addition, a one or two metre wide strip was prepared and planted with wildflower seeds along much of Chancery Road. There was also a seeded area of wildflowers at the junction with The Farthings and a two metre wide strip alongside the footpath joining Derian House with Euxton Lane.

Unlike last year, the unmown areas were, thankfully, relatively free from large dock plants. The wild grasses and naturally occurring wildflowers successfully attracted insects and, as a result, birds. Also, two wild orchids appeared out of nowhere!

The wildflower seeding worked well in many areas, notably in front of the shops at the Village Centre and along the footpath adjacent to Derian house.

Anti-Social Behaviour in the Village

Unfortunately, over the last few months there have been incidents of anti-social behaviour at the subway underpass on Chancery Road near the shops and at the West Way Sports Hub.

The ownership of the underpass is currently being clarified with Lancashire County Council. Even so, Chorley Borough Council have cleared the underpass of litter and dangerous rubbish including removing the graffiti, on a number of occasions in recent weeks.

The West Way Sports Hub have also been experiencing anti-social behaviour after the site has been closed for the day. This is being discussed with Chorley Borough Council as they are the site owners and deal with the relevant insurance companies. Young adults have been accessing the site out of hours, vandalising it and engaging in generally destructive behaviour. Often they have been scaling the fences or cutting out panels with bolt cutters to gain access to the pitches.

The local Design Out Crime team have attended the site and provided some feedback and recommendations to Chorley Borough Council who are now considering what actions to take next.

Government Support for Your Energy Bills



To support with rising costs of energy, we have compiled a list of all the government support available to date, as well as some practical tips on how you can save energy in your home.

Several initiatives have been introduced by the government and energy providers to help struggling households, depending on their circumstances:

- £400 Energy Bills Support Scheme discount this payment is for the person who
 pays the electricity bills, and provides a £400 discount (£67 a month) on your electricity
 bill between October 2022 and March 2023.
- £650 Cost of Living Payment this payment is for people who get universal credit, tax credits or other low-income benefits, and will be paid in two instalments, one in summer and another in autumn.
- £150 Disability Cost of Living Payment this payment is for anyone who receives disability benefits, and this will be a a one-off £150 payment made by October, to help with extra costs, such as specialist equipment or transport.
- £140 Warm Home Discount Scheme this payment is for people who get Pension Credit Guarantee or have a low income and will provide a one-off discount on their winter electricity bill, given they are the bill payer, and their energy provider is part of the scheme.
- £250 to £600 Winter Fuel Payment this payment is for pensioners and will provide between £100 and £300 to help with paying the heating bills, as well as an extra one-off top-up payment between £150 and £300, paid in November or October.

Contacting your energy provider

As well as the above support, <u>Ofgem</u>, the UK Energy Regulator has also advised for people to contact their energy suppliers and see if you can agree on a payment plan, or to check if you are eligible for any additional grants and benefits.

Top tips on small changes we can make around the house to save money

- Lower the temperature on your thermostat by as little as one degree, or even more if you can and layer up
- Try to keep lights off during the day and open your curtains
- Make appliances more efficient by loading up your washing up and dishwasher before using
- Check to see if appliances have eco-settings, you can turn on to use 30-60% less energy
- Get into the habit of unplugging and turning off any unused appliances at the socket, instead of leaving them on standby
- Try to take shorter showers each day
- Switch to a smart meter and see how much energy you are using, and to send more accurate readings to your energy provider

West Way Ponds Community Nature Reserve and Wildlife Educational Project

We have good news regarding the West Way Nature Reserve. We have had meetings with Chorley Borough Council to discuss the repair needed and how we can improve and enhance the area.

So far, the path leading to the Nature Reserve has been resurfaced.

Whilst the Nature Reserve is primarily for the enjoyment of Astley Village residents, we are working to develop this to be a Forest School site that Buckshaw Primary School and Little Explorers Nursery can use on a daily basis.

With the help of the Lancashire Wildlife Trust, Chorley Borough Council will be carrying out structural works to repair and improve the Nature Reserve over the winter. Once the paths, boardwalks and fencing are in place they plan to carry out wildflower planting, installation of educational and interpretation signage, bird boxes, bat boxes, hedgehog and insect houses etc. The site with all its new improvements, will be managed and maintained by Chorley Borough Council with the help of the ranger staff. The Nature Reserve can evolve and be enhanced over the years to come.
